IT IS ORDERED that the individuals identified in the attached list of names are appointed as volunteer Hearing Officers to preside over civil traffic violations in the Justice Courts of Arizona in Maricopa County, to serve without compensation, unless sooner revoked or withdrawn, from January 1, 2020 through December 31, 2020.
