WHEREAS the Justice Courts of Arizona in Maricopa County may appoint hearing officers to preside over civil traffic violation cases pursuant to A.R.S. § 28-1553 and Bench Policy Directive 4.1.9, Subject: Appointment, Retention, Administration and Assignment of Hearing Officers (effective 10/14/15), authorizes the Presiding Justice of the Peace to appoint hearing officers; and

WHEREAS the bench voted to approve these appointments at its October 7, 2020, meeting; and

WHEREAS Judge Joseph C. Welty, Presiding Judge of the Superior Court in and of Maricopa County, has indicated his concurrence with these appointments;

IT IS ORDERED that the individuals identified in the attached list of names are appointed as volunteer Hearing Officers to preside over civil traffic violations in the Justice Courts of Arizona in Maricopa County, to serve without compensation, unless sooner revoked or withdrawn, from January 1, 2021 through December 31, 2021.
