

WHEREAS the Hon. Joseph C. Welty, Presiding Judge of the Superior Court, in and for Maricopa County, has indicated his concurrence with these appointments.

IT IS ORDERED that the individuals identified in the attached list of names are appointed as volunteer Hearing Officers to preside over civil traffic violations in the Justice Courts of Arizona in Maricopa County, to serve without compensation, unless sooner revoked or withdrawn, from January 1, 2025, through December 31, 2025.
