**WHEREAS:** Bench Policy 1.2.1 establishes a standing committee system to assist the Bench and the Presiding Judge of the Peace in formulating plans and policies for the use of technology in the Justice Court system and to coordinate with the Justice Court Technology Committee in the Court Technology Division, and any other entities as necessary

**WHEREAS:** That membership in all committees serves concurrently with the term of appointing Presider and in accordance with the Bench Policy 1.2.1. Membership in the Technology Committee shall consist of at least two Justices of the Peace, along with the two court clerks recommended by the committee and appointed by the Presiding Justice of the Peace, the Justice Court IT Manager and an invitation shall be extended to Chief Information Office of the Superior Court and or their designee. One of the Justices of Peace shall be appointed Chairperson; and at the discretion of the Presiding Justice of the Peace co-chairs maybe appointed.

**THEREFORE, IT IS ORDERED** that **Yolimar Roman Martinez** be appointed as a member to the Technology Committee beginning upon signature of this Order and ending as noted.
